OUR COMMITMENT TO THE MONTROSE COMMUNITY

1. We commit that the Montrose County School District REIJ will represent the parents, children and taxpayers of Montrose County and welcome public input at monthly Board Meetings.
2. As one of our first official acts, we will propose and pass a Board Resolution to prohibit the teaching of critical race theory and any of its elements in Montrose schools.
3. All Board resolutions will be presented and discussed in open meeting prior to board voting.
4. All proposed district COVID policies will be discussed and approved or rejected by the Board.
5. The Board will review and discuss and ensure all district curriculum is appropriate for Montrose schools.
6. The Board will review and approve STEM curriculum to ensure the curriculum includes course work that will be needed to enter a desired college program.
7. The Board will conduct a thorough analysis of the school district budget in open meeting(s) and vote on approval in open meeting(s) – not pass a budget on a consent agenda.
8. Work sessions will be used to discuss district issues and not solely to make field trips to district schools. Minutes or recordings of work session discussions will be available to the public.
9. The Board will require a facilities maintenance plan be adopted to ensure our facilities are properly maintained.
10. The Board will review the district sex ed policy to ensure the curriculum meets parental approval and focuses on appropriate sexual health issues and if appropriate, offer an opt in provision for parents rather than an opt out requirement.
11. All grant applications will be approved or rejected by the Board prior to application being made.
12. The current district performance on the Colorado Measure for Academic Success (CMAS) does not reflect the potential of students in the district. We will require the administration to prepare a realistic plan to raise the CMAS scores. The plan must include measurable improvement and a realistic time line for each school in the district. Our community, especially student’s parents, deserve to know what the expectations are for the students in each of our schools.

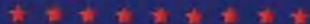
